

The Questionable Connection between AIDS and HIV

I did two interviews that really got me thinking on the relationship between AIDS and HIV. Their work convinced me to take this stand: There isn't ANY relationship between AIDS and HIV. That is NOT to say AIDS is not a real condition. It absolutely is. You can ask the friends and family members of the terrible, devastating death suffered by those with AIDS. It means the relation "created" between AIDS and HIV is false.

The second interview is with toxicologist and pathologist, **Dr. Mohammad Ali Al-Bayati, PhD, DABT, DABVT** <http://www.toxi-health.com/>

Dr. Al-Bayati has over 25 years of experience in research, teaching, diagnostic work, and serving as expert witness on many medical-legal cases in USA and other countries involving children and adults. In the interview, he demonstrates that the relationship between AIDS and HIV fails EVERY standard test used to find causes of medical conditions and shows it is the only case when the cause is adopted in the manner it has been; totally unscientifically.

In addition, Dr. Hulda Clark's research provided insight on the causes and cures to AIDS.

Dr. Clark focused on consulting and independent research in all aspects of human disease, especially cancer. This research took her down many avenues; from the study of parasites, bacteria, viruses and fungus to heavy metals, solvents and lately radioactivity. She wanted to find out how the human body cells react to these invaders. She came up with many solutions to rid our bodies of these invaders. Dr. Clark researched the use of herbs, essential oils, orthomolecular therapy and frequency therapy. The use of electronic pulses and herbs that destroy the biological sources of toxins (bacteria, parasites, flukes, etc) paired with the discovery and removal of environmental toxins has been most effective in many diseased conditions. Basketball star, Magic Johnson, publicly stating his HIV+ and retiring from the NBA, started the Anti-AIDS drug cocktails and was feeling do badly, he stopped treatment and started a regiment of organic, toxic free food and health living... and is alive and doing well today.

The tests for HIV+ are, self admittedly, not accurate in testing for HIV+. And if found to be positive, true or false, people start the AIDS drugs, which, in turn poison the user.

The AIDS epidemic in Africa stem from severe toxic environmental conditions... AND the liberal use of the AIDS vaccines.

While these shows are from several years ago, the points presented are still applicable to this day. The political and economic reasons for the institutional embrace of, not only a false diagnosis and treatment, but, one that hastens the deadliness of AIDS, is a point for another discussion. First one has to determine the falsehood of the diagnosis and treatment before moving on to the whys. And I think these three people have solidly done that.
